

Invitation to participate in a tender, with a prequalification and an additional competitive process, for designing and building 16" underwater vapor pipeline in Berth 2 of EAPC Terminal in Ashkelon

- Europe Asia Pipeline Company Ltd. (hereinafter, the "Company") is interested in building an underwater vapor pipeline with a diameter of 16" in Berth 2 of the Ashkelon Terminal, as all detailed at EAPC Sitehttps://www.eapc.co.il/tenders-page
- 2. A bid that does not meet all of the conditions set forth below may be disqualified:

General

- 2.1 The bidder has proven experience (as a prime contractor or as a subcontractor) in design, construction and quality control, according to the following standards: NACE, ASME B31.4 and API in offshore pipeline project having a length of at least 1,000 metres and a diameter of at least 10 inches, laid on the seabed at a depth of at least 20 metres, during the last 15 years, including one project that includes all of the above in a scope of at least 3 million US dollars, in Israel or abroad.
- 2.2 The bidder shall represent and warrant that if it is awarded the performance of the work, then it will have in its possession and under its management, at the relevant date, equipment that is in good working order and suitable for the performance of the work that is the subject of the tender, with this also including emergency equipment and equipment for the prevention of sea pollution, and it will employ its own trained personnel to operate such equipment (not through a subcontractor).
- 2.3 The bidder's staff (including subcontractors) shall include at least two pipe welders who are certified API 1104 or a parallel standard, with proven experience in welding fuel pipes.
- 2.4 The bidder passed all the EAPC Chief Security Officer Examination.



If the bidder is a corporation that has been duly incorporated and registered in Israel, by the deadline for submitting the documents at the Pre-Qualification Stage, it must meet the following threshold conditions:

- 2.5 The Bidder is a contractor that is registered by the Contractors Registration for Construction Engineering Work Law, 5729 1969, in the port sector, maritime work (400), at least at Class 3 'a, by the deadline for the submission of the documents in the pre-selection stage.
- 2.6 The bidder is a corporation that has been duly incorporated and duly registered in Israel by the deadline for submission of the documents at the pre-qualification stage.
- 2.7 The bidder is eligible to participate in the Tender and enter into the Contract in accordance with the relevant provisions of Israeli law concerning transactions with public bodies; and the bidder has a valid approval pursuant to the provisions of the Public Entities Transactions Law, 5736-1976
- 2.8 The bidder will declare that no proceedings are being conducted against it for insolvency, liquidation, stay of proceedings, and there is no registration of it being a company in violation of the law or under warning prior to such registration, on the deadline for the submission of the documents in the Pre-Qualification Stage.

<u>If the bidder is a foreign body</u>, by the deadline for submitting the documents at the Pre-Qualification Stage, it must meet the following threshold conditions:

- 2.9 The bidder is not subject to sanctions, investigations, or other restrictions by a governmental authority of its home jurisdiction which would render it ineligible to participate in tenders of governmental corporations or other public bodies in its home jurisdiction.
- 2.10 The bidder will undertake that as a condition for starting the performance of the work, if it is chosen as the winner at the bidding stage, it must show the Company a confirmation from the Minister of Housing and Construction that it is exempt from the application of the Law on the Registration of Contractors for Structural Engineering Works, 5729-1969 with



regard to the work which is the subject of this invitation in accordance with Section 14A of said law.

- 3. The bidders will submit the Documents to a dedicated e-mail box at the address vaporpipeline@eapc.co.il (hereinafter, the "Tender Box") by no later than February 23rd 2021 at 12:00 Israel Time.

 - It is hereby clarified that there is no obligation to take part in the above Zoom conversation and this does not constitute a threshold for participation and/or for submitting a bid.
- 5. For avoidance of any doubt, in any event of contradiction between the provisions of this notice and the provisions of the Tender's documents, the provisions of the Tender shall govern.
